Each young person is paired with a trained volunteer mentor for a full year of one-to-one mentoring focused on physical, social, and emotional wellness. Youth set and achieve personal physical-wellness goals, build lifelong healthy habits around movement, nutrition, and mental wellness, strengthen community connection through volunteering and service, and reflect on their growth and celebrate success. After completing the first year, youth are invited to continue along Bolder Options' alumni pathway, which provides ongoing opportunities for leadership, service, and career exploration. In 2024, Bolder Options supported 73 youth in 1:1 mentoring relationships, recruited, screened,

Through its alumni pathway, Bolder Options continues to engage young
people beyond their first mentoring year with opportunities for
leadership development, service learning, college and career
exploration, scholarships, and outdoor adventure learning. Alumni
attendance included 10 graduates of the I Achieve program and 18
graduates of the I Believe program, programs that focus on early career
exploration, life skills, and professional skill building. Across all
Bolder Options programs, total event attendance reached 1,434, with an
additional 644 family members participating in activities that
strengthen family and community support around youth success.
